**Sealed Bids:** Sealed Bids for the **(2ea) Enclosed Cab Mini-Excavators and (2ea) Equipment Trailers** will be received until **3:00 pm Wednesday, Dec 5, 2018** at the City of Tifton City Hall located at **130 E. 1<sup>st</sup> Street, Tifton GA 31794**, at which time and place all Bids will be publicly opened and read aloud. No bid may be withdrawn after the closing time for receipt of bids for a period of sixty (60) days.

**Instructions to Bidders:** The form shall be typed or printed in ink. All blanks in the form shall receive a response. A Bid shall be submitted no later than the date and time prescribed and at the place indicated in this document and shall be enclosed in an opaque sealed envelope plainly marked with “(2ea) Enclosed Cab Mini-excavator/(2ea) Equipment Trailers”, the name and address of the Bidder, and shall only include this letter, the completed bid form and a Certificate of Insurance. Bidder must be a vendor on file with the City of Tifton. If Bidder is not a vendor, a vendor application and W-9 form must be filled out and included with the Bid documents. If a Bid is sent by mail or other delivery system, the sealed envelope containing the Bid shall be enclosed in a separate envelope plainly marked on the outside with the notation “**BID ENCLOSED**”. It is solely the responsibility of the Bidder to verify that their Bid is present at the time and place specified in this document.
