**Deadline:** **November 1<sup>st</sup>:** Your early entry will assure you of the best spot available.

**Booth Size:** 10'x12' - if larger space is needed additional charges will be added.

**Set-Up Time:** Set-Up time is **Saturday December 7<sup>th</sup> at 4 p.m.** - Vehicles are permitted in the exhibit area for unloading only and **must be out of the area by 4:45 pm.** Exhibitors must supply their own tents, tables and chairs.

**Check-In:** **Tifton Garden next to LaCabana Restaurant at 211 Main Street.**

*No power source or water will be available!*

*All vendors must provide their own **QUIET** power generator for cooking, lighting, and water etc.*

**Please Note:** All concessions must be kept in a clean and sanitary condition at all times. **(Smoking is not allowed in Food area— Sec. 58-116. Of the Tift County Code of Ordinances)** All food booths will be required to have a working fire extinguisher on their premise. **Only the food items approved by the committee will be permitted.** Anyone who sells items not approved will be asked to leave the festival. Grease and/ or waste **MUST BE** disposed of properly and not left on the grounds. Failure to adhere to this rule may disqualify you from participating in any future Tifton events and you may be charged a fine.
