## **Board Information and Qualifications**

The below qualifications are for City of Tifton board appointees. Tift County residents seeking appointment to joint boards should contact the Tift County Clerk for board appointment opportunities.

### **Downtown Development Authority**

- 1. Member shall be a tax payer & reside inside the City of Tifton; or
- 2. Owner or operator of a business located in the DDA area and resides in Tift County; or
- 3. Person having a combination of qualifications listed above; or
- 4. A member of the governing body of the municipal corporation; or
- 5. One member may reside outside Tift County, but must own a business in the DDA area

#### **Historic Preservation Commission**

The Historic Preservation Commission administers and ensures compliance with the City's historic preservation ordinance and is part of the planning function of the City.

- 1. Be a resident of the City of Tifton; or
- 2. Operates a business within the City of Tifton; or
- 3. A majority of the board shall be persons who have demonstrated special interest, experience, or education in history or architecture

### **Keep Tift Beautiful Board**

The Keep Tift Beautiful (KTB) Board promotes a clean community and litter prevention.

- 1. City appointees should be a City Resident and recommended by the KTB Board; or
- 2. Operate a business within the City of Tifton

### **Planning & Zoning Commission**

- 1. Member shall be a resident of the City of Tifton; or
- 2. Operate a business within the City of Tifton;

#### **Zoning Board of Appeals**

The Board hears appeals where there is an alleged error in any order, requirement, decision or determination made by the City's Building Official. The Board also authorizes variances from the terms of the Zoning Ordinance in accordance with the conditions listed in the ordinance and decides on other matters where the Board's decision is necessary.

- 1. Member shall be a resident of the City of Tifton; or
- 2. Operate a business within the City of Tifton;

#### **Tifton Tree Board**

The Tifton Tree Board was created to investigate and advise officials of the city regarding the care, preservation, pruning, planting, replanting, removal and disposition of trees and shrubs located within public areas in the city.

- 1. Be a Resident of the City of Tifton or Tift County; or
- 2. Operates a business within the City of Tifton

### Tifton-Tift County Library Board

The Tifton-Tift County Public Library shall operate under the regulations governing public libraries as set forth by the State of Georgia and shall offer a full program of library service to all citizens of the county to meet their informational, educational, and recreational needs.

- 1. Be a Resident of the City of Tifton; or
- 2. Operates a business within the City of Tifton and is a County resident

### **Tifton Housing Authority Board**

The Tifton Housing Authority establishes long-term plans and sets policies to ensure the public housing needs of the community and residents are met.

- 1. Be a Resident of the City of Tifton; or
- 2. At least one member shall be a Resident of the Tifton Housing Authority;
- 3. No member shall be an officer or employee of the City

### **Tifton-Tift County Tourism Board**

The Tifton-Tift County Tourism Association promotes special tourist related events in Tifton and Tift County.

- 1. Be a resident of the City of Tifton; or
- 2. Operates a business within the City of Tifton

### **Tift County Airport Authority**

- 1. Be a resident of the City of Tifton; or
- 2. Operates a business within the City of Tifton

## **Urban Redevelopment Authority**

The Tifton Urban Redevelopment Agency focuses on improving the blighted areas of the city.

- 1. Be a resident of the City of Tifton; or
- 2. Operates a business within the City of Tifton
